



The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.

15. That the school will ensure that the school fulfills all essential requirement before applying for affiliation and will fulfill all other conditions post affiliation and comply with all the general rules as given in the affiliation byelaws or notified from time to time.

16. That the school will not start CBSE pattern classes without submitting a commencement certificate to the efect that the school has complied with all the conditions imposed by CBSE and the post-affiliation conditions contained in affiliation byelaws along with general rules

That state pattern classes IX and X running prior to the affiliation to CBSE would be sponsored for the State Board Examination. State Pattern classes IX and X will be closed in a phased manner. No admission will be taken in the State Board Pattern class IX and X after getting affiliation from CBSE. The State Board School will be discontinued after switchover to CBSE.
